MINUTES

The meeting was called to order by the Supervisor, James Dubay, at 6:04 p.m.

Motion made by Fantozzi/Day to approve the agenda. Motion carried.

Motion made by Snyder/Rivard to approve the August 14th minutes. Motion carried.

Treasurer read her report. Motion made by Day/Rivard to approve the treasurers report. Motion carried.

Motion made by Dubay/Rivard to pay the bills. Motion carried.

<u>Fire Dept</u> Fire Chief Brad Hoffman gave fire report. 10 total runs – 8 medical, 1 personal injury, 1 fire (Beaver Twp)

Fire Dept is having an issue with toilets not flushing. Dubay will bring home a commercial snake and snake the clean out to see if this fixes the problem.

Fire Dept would like to purchase 6 handheld radios with original purchase price of 6000.00 but Motorola is having a 61% off sale plus Central Dispatch is looking at a grant for area fire departments that would bring the cost down to 19%. Final price would be $1140 \times 6 = 6840$. If the grant etc. does not come through, the Fire Department will not proceed with the purchase. Motion made by Snyder/Day to proceed with this purchase based on the above.

The engine and tanker are going to Beaver Township on 9-18-17 for pump testing. Approx cost \$2000. As the Vehicle Maintenance does not have enough money to cover this, Fire Dept requested the remaining necessary funds be diverted from the Fire Fund Equipment Maintenance category once the final bill is received. Motion made by Fantozzi/Day. Motion carried.

McLaren Bay grant – Dubay has not checked into this yet.

Jim Yuel from EMC Insurance just sent his report on the Fire Dept to Snyder who will disburse to the Fire Dept at their meetings on policies.

Road Projects- Gravel

Bay Mid Line Road has been held up due to a call to use limestone rather than brown gravel. Dubay just got reply from Road Commission tonight that indicates the cost will not change from \$8,625 for this change. Motion made by Day/Rivard to proceed with the change to limestone on this project and Dubay given approval to call our authorization into the Road Commission. Motion carried.

Dubay did not call Mt Forest regarding Townline 16 but did determine with the Road Commission that Mt Forest owes us a mile of road. Dubay to call Mt Forest

Supervisor to determine if this project can be changed to limestone, the fact that we will split the cost of 2 miles of road, and that Mt Forest will do the other mile of the original 3 proposed miles. Dennis Landosky will provide phone numbers to Dubay on possible outside sources of limestone for a much cheaper cost for this project.

Snyder is calling the Road Commission about putting down limestone on Carter Road from Erickson to Newberg in preparation for chip and seal next year and obtain a final cost on this part of the project (approx. \$27000 according to previous bid on this road earlier this year).
