Motion made by Rivard/Snyder to approve the March 12, 2018 Regular Meeting minutes. Motion carried.

Motion made by Day/Rivard to approve March 31, 2018 Settlement Meeting minutes. Motion carried.

Motion made by Snyder/Rivard to approve March 31, 2018 Budget Meeting minutes. Motion carried.

Treasurer's report read by Snyder. Motion made by Day/Rivard to approve the treasurers report. Motion carried.

Mutual aid received once and mutual aid given 3 times

Insurance compliance issues are in progress with only 2 issues still open. Tools on the engine need to be secured. Items needed to do this have been received and will be installed as soon as possible.

Basement fire training in Lansing (training is free). Mileage requested for possibly 2 to 3 vehicles for as many firefighters as want to/can attend. Motion made by Day/Snyder. Motion carried.

Air bottles need testing (company in Freeland) at \$20 per each bottle (12 in total). Motion made Snyder/Rivard. Motion Carried.

Ladder testing needed at \$1.55 per foot for approximately 100 feet of ladder. If stickers need reapplication they are 2.50 for regular stickers and 3.00 for electric shock stickers. Motion made by Day/Rivard. Motion carried.

Jaws of Life testing - \$410 plus approximately \$95 for mileage. Motion made by Day/Rivard. Motion carried.

Testing air packs on engine (by Apollo) at \$60 for each of 6 air packs. (\$360 total). Motion made Snyder/Rivard. Motion carried.

2 of 3 AED's at Fire Dept are involved in current recall. The Asst Fire Chief is working on getting them replaced/repaired etc.

On Wednesday, April 11, 2018 there is a statewide tornado drill at 1 p.m.

Discussion on term of both Fire Dept millages being sought. Fire Dept wanted to stay with 4 years.
